Policy Statement Equal Employment Opportunity

It is the policy of Brown Physicians, Inc. not to discriminate against any employee or applicant for employment based on gender, race, religion, color, national origin, physical or mental disability, marital status, age, gender identity or expression, citizenship, genetic information, ancestral origin, sexual orientation, pregnancy, childbirth, veteran or disability status, or any other related medical conditions or any other status protected by Federal, State or local laws.

Furthermore, Brown Physicians, Inc. will provide equal employment and advancement opportunities to all qualified individuals. To achieve this goal, Brown Physicians, Inc. is dedicated to taking affirmative action to employ and advance in employment, protected veterans and individuals with disabilities. 3. Opposing any act or practice made unlawful by VEVRRRA, Section 503 or its implementing regulations in this part, or any other Federal, State or local law requiring equal opportunity for individuals with disabilities.
4. Exercising any other right protected by VEVRRRA, Section 503 or its implementing regulations.

As Executive Director of Brown Physicians, Inc., BPI is committed to the principles of Affirmative Action and Equal Employment Opportunity. To ensure dissemination and implementation of equal employment opportunity and affirmative action throughout all levels of the organization, a Coordinator will be appointed for each BPI affiliate. One of the Coordinators duties will be to establish and maintain an internal audit and reporting system to allow for effective measurement of Brown Physicians, Inc.'s programs.
